## CONTINUING EDUCATION

### **Association of Social Work Boards (ASWB)**

ABCSW, #1854, is approved as an ACE provider to offer social work continuing education by the Association of Social Work Boards (ASWB) Approved Continuing Education (ACE) program. Regulatory boards are the final authority on courses accepted for continuing education credit. ACE provider approval period: 8/23/2023 – 8/23/2024. Social workers completing this course receive up to 20 continuing education credits/hours.”

### **Continuing Education Certificate Requirements**

Registered conference attendees must fully attend each chosen session to be eligible for Continuing Education Credit/Hours.
